Before beginning assembly, make sure all parts needed are present.

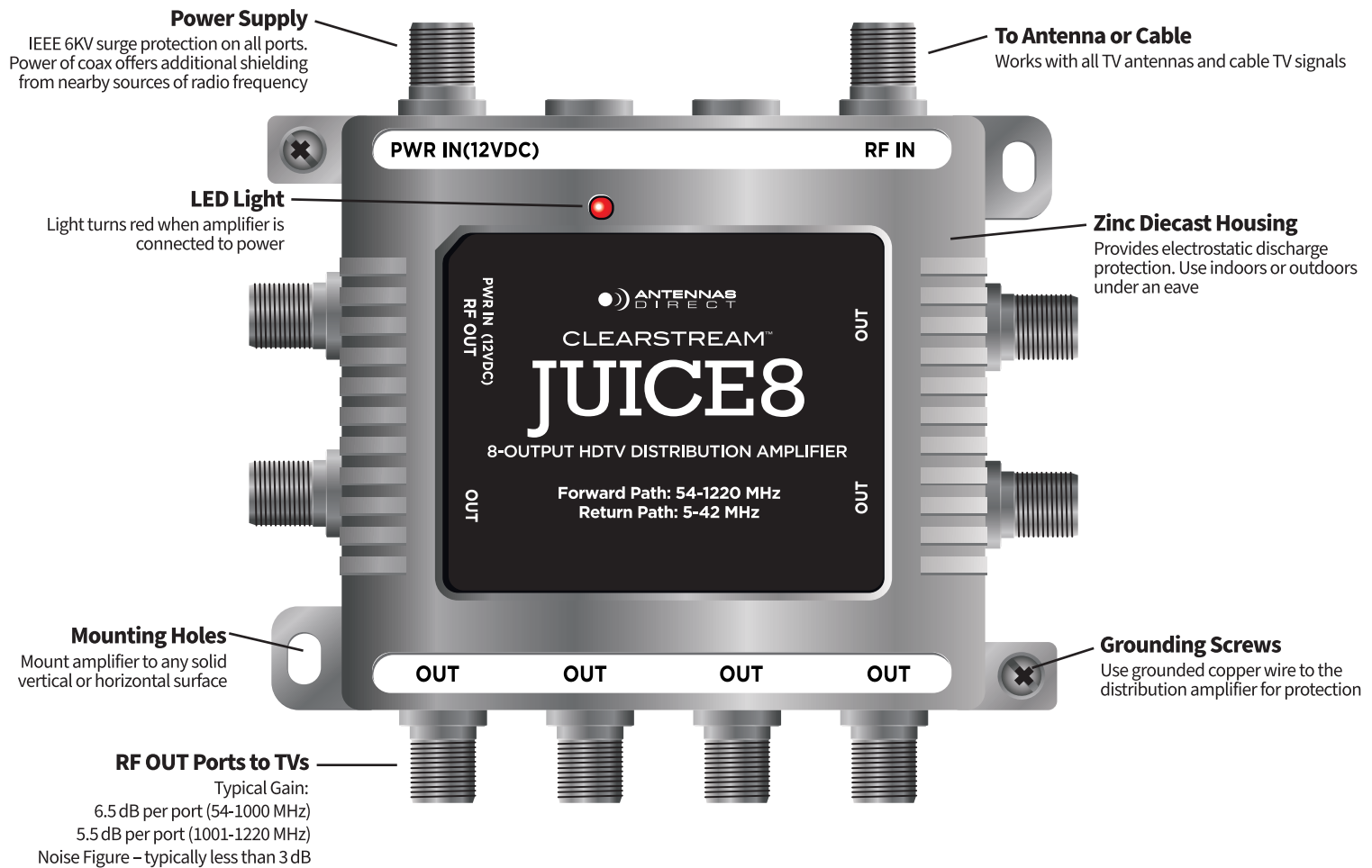
READ BEFORE INSTALLATION:

Before permanently attaching the distribution amplifier to any surface, make sure you install the device in a central location to service all your TVs.

- 8-Output HDTV Antenna Distribution Amplifier
- 40 in. Coaxial Cable
- Power Supply (for indoor use only)
- 2 Wall Screws
- 2 Grounding Screws (shown below)



INSTALLATION TIPS:

The JUICE8 meets water-proof standard IP64 and is fully protected against dust ingress as well as water splashes from any direction.

Before permanently installing the distribution amplifier, find a location to serve as a central distribution point for the amplifier. Install the distribution amplifier on a solid surface using the wall screws.

Make all the coaxial cable connections to the 8-output distribution amplifier before plugging the device into a wall outlet.

Once the power supply is plugged in, the amplifier is on. There is no on/off power switch. The LED light should be illuminated.

WARNING: RISK OF ELECTRICAL SHOCK. Do not open the zinc housing. Do not expose the distribution amplifier directly to water/rain.

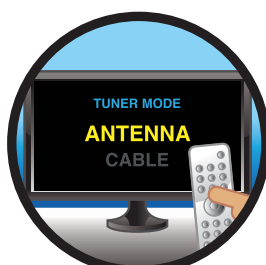
